Credential Definition

NAME

TOGAF® Essentials 2018

DESCRIPTION

Individuals who have earned the TOGAF Essentials 2018 credential have proven to have up-to-date knowledge and understanding of the changes introduced to the TOGAF Body of Knowledge in 2018. The TOGAF Body of Knowledge includes the TOGAF Standard, Version 9.2 and the TOGAF Library.

This credential is required for trainers to be authorized to deliver Accredited Training Courses based on the TOGAF Standard, Version 9.2.

CREDENTIAL CRITERIA

The earner has attended a minimum of three (3) hours training on the subject and passed the TOGAF Essentials 2018 assessment.

APPLICATION PREREQUISITES

Applicants are required to be TOGAF 9 Certified (TOGAF 9 Level 2).

EDUCATION EXPERIENCE

The path to achieve the TOGAF Essentials 2018 credential is to complete the eight (8) Learning Units defined in the Conformance Requirements Document and a pass result for the TOGAF Essentials 2018 assessment.

INDICATOR OF COMPLIANCE

Candidates are required to have passed the TOGAF Essentials 2018 assessment. The assessment consists of 20 questions in simple multiple-choice format with a 75% pass mark (15/20).

DURATION

The duration of the credential is indefinite – this credential is to a given version of the Body of Knowledge and does not expire, so there are no re-certification or renewal requirements.

STANDARDS

The TOGAF Standard, Version 9.2 (Doc. No. C182)

RECOMMENDATIONS

Individuals who have earned this credential are recommended to consider additional credentials related to contents of the TOGAF Library in The Open Group Credentials Program.
